Notice Regarding Repurchase of treasury shares

(Acquisition of Treasury shares pursuant to provisions in the articles of incorporation based on Article 459, Paragraph 1, Item 1 or Article 165, Paragraph 2 of the Companies Act)

CHINO CORPORATION(the “Company”) hereby announce that at the Board of Directors meeting held on November 12, 2025, we resolved on matters concerning the acquisition of Treasury shares based on the provisions of the Articles of Incorporation pursuant to Article 459, Paragraph 1, Item 1 or Article 165, Paragraph 2 of the Companies Act, as follows.

1. Reasons for Acquiring Treasury Shares

The purpose of the share buyback is to enhance shareholder returns while improving capital efficiency.
